#### 1. APPROVAL OF JANUARY 13, 2021 MINUTES [WARE]

Commissioner DaCosta moved to accept the minutes. Commissioner Turrentine seconded, with Commissioners DaCosta, Turrentine, Barron, Hinshaw & Ware voting for. Motion carried 5-0.

Make Texas Beautiful – Commissioner Hinshaw working on an annual report of Parker activity. Discussion of going for Gold Star recognition which would make Parker eligible for grants. 5. DISCUSSION AND/OR APPROPRIATE ACTION ON TRASH FREE TEXAS [BARRON/DONNA DACOSTA]

Discussion of possible membership with Trash Free Texas. The organization has an online registry connecting volunteers with litter clean up opportunities. Parker can upload a list of sites that we would like to be cleaned. Interested volunteers can view the listed sites.

Per Donna DaCosta, there's no downside to participating in the program - may give us access to additional tools. The Commission would need to decide on a list of sites to enter. Chair Barron to discuss further with the city.

If TxDot manages the road adoption program on Dillehay, it's not done well. Adopt/ signs from TxDot program

Barron moves to move forward with Trash Free Texas and develop a list of sites. Commissioner Hinshaw seconded with Commissioners Ware, DaCosta, Hinshaw, Turrentine & Barron voting for. Motion carried 5-0.

Per Chair Barron, Alternate Rick Debus is working with a scout who needs a project. Discussing possibility of building a sign for the Preserve.
