# Municipal Court

**HOW MUCH IS MY FINE?** Refer to the chart on the back of this sheet for fine amounts. You must pay your citation by check or money order, payable to **City of Parker** once you have your paperwork from the Court or decide to just pay your fine. Payment plan options require a \$25.00 state “time pay” fee for each offense; contact the court for more details (972) 442-6999 x223.

**PLEASE ALLOW TWO (2) WORKING DAYS BEFORE CONTACTING THE COURT ABOUT YOUR CITATION**

**WHAT ARE MY OPTIONS?** You may be eligible for Defensive Driving or Deferred Adjudication. If you comply with the terms, the citation will not go on your driving record.

❖ : **Note special circumstances that effect eligibility**

- ✓ **If you are under 17** - You will receive a letter setting a court date to appear before the Municipal Court Judge to discuss your options.
- ✓ **If citation is for 25 mph or more above speed limit** - You are **not** eligible for the Defensive Driving option
- ✓ **If you have a CDL license** - You are **not** eligible for Deferred Adjudication or Drivers Safety Course.
- ✓ **If you were speeding in a Construction Zone** (Fines double, contact the Court for cost) - You are **not** eligible for Deferred Adjudication or Drivers Safety Course.

**DEFENSIVE DRIVING ELIGIBILITY: (Moving violations only)**  
**DO NOT TAKE COURSE UNTIL YOU CONTACT COURT**

- ✓ Must have a valid Drivers License
- ✓ Must have valid vehicle liability insurance
- ✓ Must **not** have taken a defensive driving course in the 12 months previous to the date of alleged offense

Fees:

- ✓ \$103.00 State and Municipal Fees paid at time of application
- ✓ \$10.00 fee to Texas Dept. of Public Safety for copy of Drivers Record
- ✓ Fee for State approved Driver Safety Course (price varies)

*After request is granted by the Judge, you will receive a letter in the mail advising that you may complete a state approved driver safety course within 90 days*

- ✓ Mail in “signed” “**Court Copy**” of certificate of completion

**DEFERRED ADJUDICATION ELIGIBILITY:**

- ✓ Must not currently be on deferred adjudication
- ✓ Must not have received more than 4 citations in last 12 months

Fees:

- ✓ Must pay price of violation (see chart on back ) at time of application

*After request is granted by the Judge, you will receive a copy of the Order of Deferred Adjudication defining the probationary terms & conditions*
