Description of Agenda Item:

The Monthly Financial Report provides the Year-to-Date Budget Report for all funds and a Revenue Report for the major sources of income in the General Fund. These reports cover the month-end August 31, 2024.

Year-to-Date Budget Report

The Year-to-Date Budget Report compares the budgeted expenditures and revenues to actual expenditures and revenues. In reviewing the Year-to-Date Budget Report through August 31, 2024, the City Council should note that the report lists revenues and expenditures for the fiscal year. Therefore, it is generally desirable for year-to-date revenue totals to have achieved 92% of the budgeted amount and expenditures should generally not exceed 92% of the budgeted amounts. However, because property taxes are primarily received during the first trimester of the budget year and other revenues such as franchise fees are cyclical, revenues will not always equate to the projected percentage. Likewise, total expenditures may not always equate to the projected percentage, because payments for contracted services, insurance, and debt services are paid in lump sum amounts. The City's fiscal year ended on September 30, 2023.

Revenue Reports

The Revenue Reports provide an analysis of the major revenue sources for the General Fund. They contain the current year and 4 years of historical information. Reports have been provided for the below revenue sources.

- Property Taxes

Property Taxes account for 77.4% (or \$5,149,778) of the total General Fund Budgeted Revenue. The City has received \$5,161,206 (or 100.2%) Y-T-D. The majority of property taxes are received in the months of December through February.

- Sales Taxes

Sales Taxes account for 5.7% (or \$383,000) of the total General Fund Budgeted Revenue. The City has received \$358,814 (or 93.7%) Y-T-D. Generally, sales tax collections represent two months ago actual sales reported by vendors to the State of Texas.

- Franchise Fees

Franchise Fees account for 4.5% (or \$302,000) of the total General Fund Budgeted Revenue. The City has received \$293,901 (or 97.3%) Y-T-D. These fees are typically received on a quarterly basis.

- Licenses & Permits

Licenses & Permits account for 2.4% (or \$160,000) of the total General Fund Budgeted Revenue. The City has received \$321,987 (or 201.2%) Y-T-D.

- Court Fines

Court Fines account for 3.2% (or \$215,000) of the total General Fund Budgeted Revenue. The City has received \$242,636 (or 112.9%) Y-T-D.

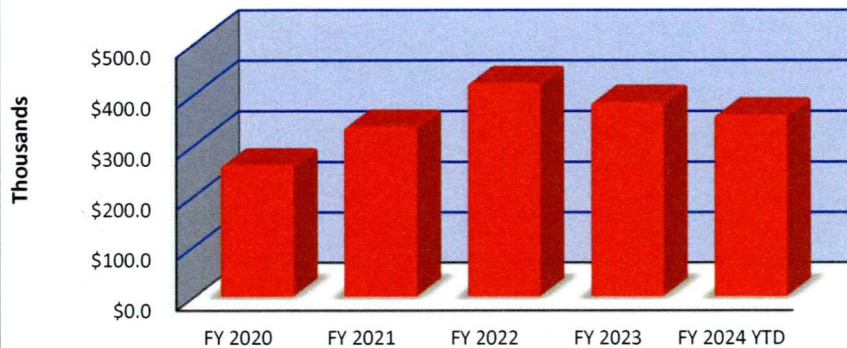

Sales Tax Revenue by Month



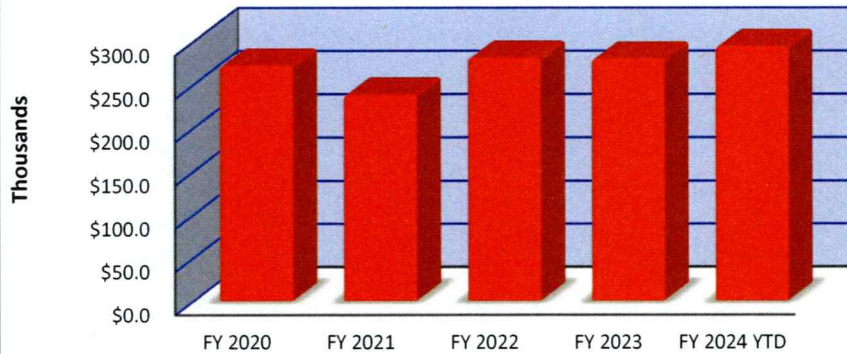

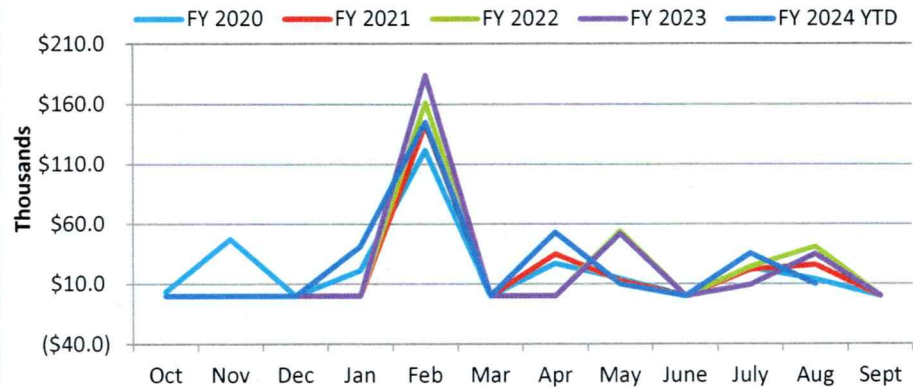

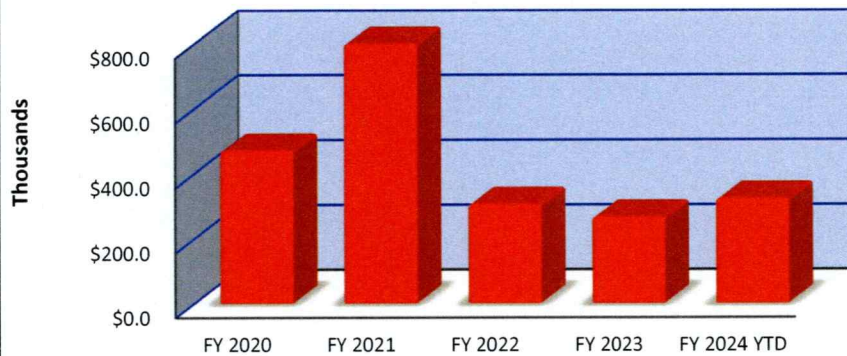

Licenses & Permits Revenue by Month

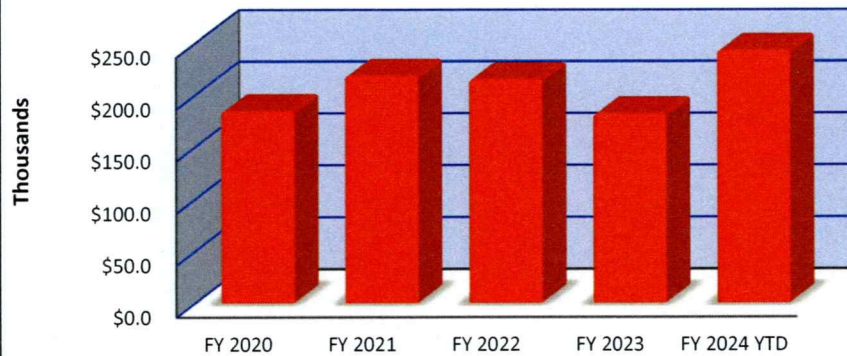
