

ORDINANCE NO. 738
(Budget Amendment 2015-2016)

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARKER,
COLLIN COUNTY, TEXAS, FINDING THE NEED TO AMEND THE
2015-2016 MUNICIPAL BUDGET FOR MUNICIPAL PURPOSES,
APPROVING THE 2015-2016 BUDGET AS AMENDED, RATIFYING
THE EXPENDITURES MADE DURING THE 2015-2016 BUDGET YEAR,
PROVIDING A SEVERABILITY CLAUSE, AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the City Council of the City of Parker utilized diligent thought and attention to the preparation of the 2015-2016 budget; and

WHEREAS, circumstances arose during the fiscal year which required the expenditure of additional funds in some of the line items of the budget, for which there is more than adequate funding in the line item for contingent expenses, and/or other line items in the budget for which expenses have been less than anticipated, creating a surplus; and

WHEREAS, the City Council finds the expenditures identified below are reasonable, necessary, and for municipal purposes, and the Budget should therefore be amended;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
CITY OF PARKER, COLLIN COUNTY, TEXAS, AS FOLLOWS:**

SECTION 1. FINDINGS. The City Council finds the statements made in the preamble above are true.

SECTION 2. SOURCES OF FUNDS. The City Council further finds the line items shown in Exhibit A with surplus balances have sufficient funds to be transferred to the line items identified in Exhibit A with balances, for which the needed expenditures will have exceeded the originally budgeted amounts. The total amount expended will not exceed the total amount of the budget as originally passed.

SECTION 3. APPROVAL OF AMENDED BUDGET. The City Council further approves the revised budget for the City on file with the City Secretary, and it is incorporated herein for all purposes. The Amended Budget is hereby approved by the City Council.

SECTION 4. AUTHORIZATION. The Mayor is authorized to make the transfers as set forth above, and file, or cause to be filed, a true and correct copy of this Ordinance, with the attached amended budget, with the City Secretary, and in the office of the County Clerk of Collin County, Texas. The expenses set forth are approved by the City Council.

SECTION 5. SEVERABILITY CLAUSE. It is the intent of the City Council that each sentence, paragraph, subdivision, clause, phrase or section of this Ordinance be deemed severable and, should any such sentence, paragraph, subdivision, clause, phrase or section be declared invalid or unconstitutional for any reason, such declaration of invalidity or

unconstitutionality shall not be construed to affect the validity of those provisions of the Ordinance left standing.

SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect immediately from and after its passage.



INTERLOCAL AGREEMENT

BETWEEN COUNTY OF TARRANT AND _____, TEXAS

This Agreement is made this _____ day of _____, 20____ between the County of Tarrant, Texas and _____, Texas.

Pursuant to the authority granted by the "Texas Interlocal Cooperation Act," Chapter 791 Texas Government Code providing for the cooperation between local governmental bodies, the parties hereto, in consideration of the premises and mutual promises contained herein, agree as follows:

WHEREAS, the contract is made under the authority of Sections 791.001-791.029 of the Texas Government Code; and,

WHEREAS, the parties, in performing governmental functions or in paying for the performance of governmental functions hereunder shall make that performance or those payments from current revenues legally available to that party;

WHEREAS, the governing bodies of each party find that the subject of this contract is necessary for the benefit of the public and that each party has the legal authority to perform and to provide the governmental function or service which is the subject matter of this contract; furthermore, the governing bodies find that the performance of this contract is in the common interest of both parties; and that the division of cost fairly compensates the performing party for the services under this contract.

I.

_____ hereby makes, constitutes and appoints Tarrant County its true and lawful purchasing agent for the purchase of various commodities using Annual Contracts (Bids). Tarrant County will maintain a listing of Annual Contracts which are available for local entities use. Tarrant County will forward a copy of requested Annual Contract to the requesting entity. _____ agrees that Tarrant County shall serve as the purchasing agent for selected items, and agrees that the bidding shall be conducted by Tarrant County according to its usual bidding procedures and in accordance with applicable State statutes.

II.

_____ agrees that all specifications for selected items shall be determined by Tarrant County.

III.

_____ agrees to pay the supplier for all goods, equipment and products pursuant to this Agreement. The successful bidder or bidders shall bill _____ directly for all items purchased, and _____ shall be responsible for vendor's compliance with all conditions of delivery and quality of the purchased items.

IV.

_____ (name), _____ (title) is hereby designated as the official representative to act for _____ in all matters relating to this Agreement.

V.

This Agreement shall take effect upon execution by both signatories.

VI.

This Agreement shall be in effect from the date of execution until terminated by either party to the Agreement upon written thirty (30) days notice prior to cancellation


